Dawdncy to check on him while she was checking Segregation. She advised that he was breathing and making noises. At 1825 hrs O/C. Griffin's checked Seg and Inmate Rayner was still laying on the floor making noise and Breathing. At 1912 hrs O/C Griffin's returned to check seg and Inmate Rayner was still laying on the floor making noise. At 2000 hrs Sgt. Dawdncy came and checked seg and again Inmate Rayner was still Laying on the floor making



Noise that I could hear thru the intercom. At 2019 hrs Cpl Merced checked Seg and Inmate Rayner was still laying on the Floor and still making noises that I could hear on the intercom. At 2108 hrs OFC Griffis checked Seg and Inmate Rayner was laying on the Floor breathing and making noise that was loud enough to hear on the intercom. At 2129 hrs Cpl Merced checked Seg and Inmate Rayner was still on Floor making noises that was heard on the intercom. At 2157 hrs I, OFC Edwards, observed Inmate Rayner had not moved, so I call OFC Griffis to come check on him because I had stopped hearing noises and he would not respond to me over the intercom. Upon OFC Griffis's arrival, he noticed Inmate Rayner was not breathing and he called it in and began CPR. I, OFC Edwards arrived moments later to assist OFC Griffis with CPR until EMS arrived and took over. End of Statement
